

- A 30 minute consultation is required prior to having Microblading. The cost is \$25 which will be applied to the final total. Your Microblading procedure fee is \$\_\_\_\_\_ which includes the 6-8 wk touch up. Scheduled appointments for the touch up procedure require 48 hours notice for cancellation or rescheduling. The touch up visit is included in the price only when performed within 8 weeks of the initial session. Past 8 weeks or if appointments are missed an additional charge will be incurred.

- A \$50 deposit is required to schedule your Microblading, which is applied to your final total. This is non refundable because we are setting aside a 3-hour time slot especially for you. If you need to reschedule your Microblading for any reason you may keep your \$50 deposit at the appointment. If we are given 2 weeks notice. If we do not have 2 weeks notice, we will unfortunately need to collect another \$50 deposit to reschedule.

#### AFTER CARE INSTRUCTIONS for Microblading

Follow these instructions for 2 weeks following your procedure to improve and prolong results. I have applied a liquid barrier that will stay on and protect your microblading area. Avoid getting anything on the brow/eye area including water, except for cleansing as directed. You may blot for the first few hours with sterile gauze to remove any excess fluids, if necessary.

**CLEANSING:** In 2-3 hours wash lightly with slightly damp Qtips and antibacterial soap like orange Dial soap or green (non-scented) soap. Repeat this very gently during days 1-4. Washing should be very gentle with hardly any water. Do not attempt to remove the barrier film if it was applied. Allow it to come off naturally over time. Please avoid saturating brows/eyes with water. After the initial 3 days of washing you may very sparingly apply balm to hydrate your brow for dryness relief. Do not pick or rub the site. The flakes must fall off on their own or you will risk removing the color and possibly scarring.

- Do not soak the treated area in the bath, pool or hot tub. For 30 days refrain from swimming in salt water or chlorinated pools, saunas, hot yoga, steam rooms or sun beds.

- No exercise for 14 days. After that, wear a sweat band to avoid sweat on the brow/eye area

- Do not expose the area to direct sunlight for 30 days. After that, use sunscreen

- No makeup should be applied directly to the site (brow/eye liner) during healing period.

- Do not touch, rub, pick or scratch your site following treatment or during the healing period.

- You may find scabs on the area or become slightly dry following treatment.

If they itch - DO NOT SCRATCH - You may tap the brow area to alleviate the itch.

- If the site gets wet, pat the area dry with a towel. DO NOT RUB.

- Avoid using daily skin care products directly on the area.

- If you are planning a chemical peel or medical procedure, inform the therapist of the procedure you have had. Your other procedure should only be done after the healing process is complete.

- If you are due to give blood after the procedure, please inform your nurse about the microblading treatment you have had as this might alter the results.
